2021 ANNUAL MEETING MINUTES

Chair Eddie Hays called the 2nd Annual Membership meeting to order at 5:30 P.M. at 1490 Union University Parkway, Jackson, TN. He explained that due to the ongoing COVID-19 national pandemic, the meeting is being conducted virtually with a limited in-person audience.

Chair Eddie Hays lead the invocation.

Chair Eddie Hays called upon Secretary Ron Hill to determine whether a quorum was present. Secretary Hill confirmed that a quorum was present.

Chair Eddie Hays called for the reading of the minutes of the 1st Annual Membership meeting conducted on July 21, 2020. A motion was made to dispense with the reading of the last year's minutes which are in the 2020 Annual Report that is online. The motion carried and the minutes were approved as presented.

Chair Eddie Hays introduced the other Foundation Board Members:

- Mr. Ron Hill, who also served as Vice-Chair and Secretary
- Mrs. Karen Taylor, who also served as Treasurer
- Ms. Stephanie Riley
- Mrs. Mary Lou Adams

Chair Eddie Hays called upon Foundation President, Mrs. Leigh Anne Bentley, for the President's Report. President Bentley stated that in 2020 the Leaders Education Foundation was able to accomplish great things while supporting education in the community. The Foundation welcomed over 150 new members in 2020 and participated in Giving Tuesday with a \$20,000 donation match by Leaders Credit Union. She then thanked and recognized the Foundation's Corporate Charter Sponsors:

President Bentley also thanked and recognized Charter members who had each donated over \$500 to the organization. She reported that Leaders Education Foundation was awarding 12 scholarships totaling \$15,000. The recipients, who were recognized individually after the Scholarship Committee was introduced, were selected by the Scholarship Committee and approved by the Board at its last meeting in accordance with the Bylaws. The Scholarship Committee members were comprised of two Board members and one Foundation member. They were: Mrs. Mary Lou Adams, who served as the Committee's Chair; Mrs. Stephanie Riley; and Mr. Joey Hale.

President Bentley reported that the Foundation awarded \$10,000 in L.E.A.D.S. Grants to Educators in the Fall of 2020. She stated that these grants are designed to assist educators and promote initiatives that help students Learn, Experience, Advocate, Dream and Serve. Through the program, West Tennessee educators were eligible to enter for an opportunity to win one of the 10 L.E.A.D.S. Educator Grants of \$1,000 each.

President Bentley stated that the Foundation had joined with Imagination Library Chapters in Madison, Gibson, and Chester Counties to Give Forward through the Foundation's new "Imagine the Possibilities" campaign. Based on this initiative and the Board's decision to provide additional support to each participating Imagination Library, the Foundation is making a total collective donation of \$10,000. Through this campaign and donation, over 160 children will be helped to get on the road to reading.

President Bentley then introduced the 2021 Nominating Committee Chair, Mr. Ron Hill. He began by recognizing his fellow 2021 Nominating Committee members: Mrs. Karen Taylor; Mr. Spencer Pratt; Mr. Seth Rudd; and Mrs. Karen Freeman. He reported that the Committee recommended to the Board, which has voted to approve the recommendation, to increase the Board's size to seven Directors by adding two additional Directors with one serving an initial term of one year and the other serving an initial term of three years. At this time and based on the Board's approval, the Nominating Committee submits the following slate of nominations for the Foundation's Board of Directors:

Chair Eddie Hays thanked the 2021 Nominating Committee. As there were no further nominations, he asked for a motion to accept the slate of nominees. Member Todd Swims made a motion to accept the nominations, with member Karen Taylor seconding the motion. The motion carried unanimously.

Chair Eddie Hays thanked those members joining in-person and virtually for the 2nd Annual Membership meeting. He thanked all of the Foundation's sponsors, members, and donors and encouraged everyone to continue donating and, if not a member, to join the Foundation. With no other business to be discussed, Mr. Ron Hill made a motion to adjourn. Mrs. Mary Lou Adams seconded the motion. The motion carried unanimously.


